## Schedule of Events to Celebrate the 225<sup>th</sup> Anniversary of The Federal District Court in New York

Special Session of Court	Tuesday, November 4, 2014, 4 p.m.	On the first Tuesday of November, 1789, District Judge James Duane of the District of New York held the first session of any court under the new U.S. Constitution. To commemorate the event, a Colonial Fife & Drum Corps will lead the procession into the Ceremonial Courtroom (9- floor Moynihan Courthouse) with the U.S. Marshal carrying the Silver Oar of the Vice Admiralty Court of the Province of New York. Remarks will be delivered by Chief Judge Preska, Judges Haight, Castel & Batts and Robert Fiske, Jr. A reception will follow.
Historical Display	Tuesday, November 4, 2014	The Commission of Judge James Duane (NYHS) signed by President Washington and the President's letter of transmittal will be displayed next to Judge Duane's portrait on the 9th floor of the Moynihan Courthouse. The Commission of Judge John Sloss Hobart (National Archives) signed by President John Adams will also be displayed with his portrait. The original Minute Book from 1789 will be shown with other historical manuscripts.
Courtroom Sketch Art Exhibit	Tuesday, November 4, 2014 through Monday, May 4, 2015	Twenty-one pieces of Courtroom sketch art will be on display in the main lobby of the Thurgood Marshall Court House (40 Foley Sq.), including sketches from the trials of Imelda Marcos, Leona Helmsley and Martha Stewart and the sentencing proceeding of Bernard Madoff. Sketch art from the suit by Mrs. Jacqueline Onassis against photographer Ron Galella, the Mitchell-Stans trial, the trial of General Westmoreland against CBS, the trial of Ariel Sharon against Time, Inc. and several high profile organized crime or terrorism cases will be showcased.
