- 1. By submitting your request, in writing, on the court's request for a certificate of good standing/wall certificate form signed by the attorney making the request, to the United States District Court, 40 Foley Square, New York, NY 10007, Attention: Attorney Services. The form must include the attorney's name, date of admission, bar number, and must be accompanied by the appropriate fee. You must also provide a self-addressed stamped envelope.
- 2. By the attorney appearing in person at Attorney Services and showing proper identification or a designee of the attorney may appear in person at Attorney Services with the request for a certificate of good standing or wall certificate form. Said letter of authorization must be signed by the attorney making the request, on the firm's letterhead and addressed to the United States District Court, 40 Foley Square, New York, NY 10007, Attention: Attorney Services. The certificate of good standing/wall certificate form must include the attorney's name, date of admission, bar number, and must be accompanied by the appropriate fee.

In White Plains:

1. By submitting your request, in writing, on the court's request for a certificate of good standing/wall certificate form, signed by the attorney making the request, to the United States District Court, 300 Quarropas Street, White Plains, NY 10601. The form must include the attorney's name, date of admission, bar number, and must be accompanied by the appropriate fee. You must also provide a self-addressed stamped envelope.

or

2. By the attorney appearing in person at the Clerk's Office, Room 147 and showing proper identification or a designee of the attorney may appear in person with a letter of authorization. Said letter of authorization must be signed by the attorney making the request, on the firm's letterhead and addressed to the United States District Court 300 Quarropas Street, White Plains, NY 10601. The certificate of good standing/wall certificate form must include the attorney's name, date of admission, bar number, and must be accompanied by the appropriate fee.
